- 2. Public comments- None.

## 3. Discussion items:

- a. MMGY September Monthly Report MMGY's team reviewed the campaign to date. Benchmarks were exceeded prior to the fires which resulted in conversions, paid social media efficiency and CPA to all decline. LA remains our primary market. Creative refresh messages for brand with different video lengths and the gas card offers were presented. MMGY with provide their overview presentation the short videos to Nellie.

- c. Motion by the Board to create three vacant seats two in the 20-50 room property size (America's Best and Majestic Inn) and one in the 51-99 category (Holiday Express). Anil motioned; Robert seconded and passed unanimously.
- Anil motioned to reappoint the Visalia TMD officers as follows for the 2021 calendar year: Chair – Samantha; Vice Chair -Carrie; Secretary – Robert and Treasurer – Anil. Robert seconded and motion passed unanimously.
- e. Anil motioned to re-elect Robert and Carrie for another 2 year term expiring December 31, 2022. Samantha seconded and motion passed unanimously.
